Regular Meeting

Item I The regular meeting was called to order at 6:30 pm by Board President Randy Yanowski.

Item II Prayer was given by Nikki Screws.

- 1) There were no recognitions
- 2) Rory Cox discussed the finances through the end of September.
- 3) The bills were reviewed.
- 4) Jay White discussed the recent changes to the student dress code.
- 5) Mr. Daryl Stuard gave the Superintendent's report. We have had a great start to the year. All of the teachers are doing a great job from what I can tell so far. I think I have already covered this but wanted to make sure. All campuses and the district met the standards set by the state on our accountability Rating. Within the next couple of months I expect to get the TAPR report. The plan is to start the window installation towards the end of October. I received a bid back from Shannon Pruitt on the bus barn for \$155,450.00. I am in the process of working with the construction company that is helping me to see what the next step is. Like I told you earlier we are splitting the cost of the problem with the electrical lines being cut with the turf company. We are still battling the HVAC units. Now the problem is the Boiler. Even the rooms that are cold have a high humidity. They are in the process of repairing the boiler. Current enrollment is 463. Seven of those are non-qualifying Pre-K students so we are at 456. Last year we had 431. Volleyball is here tomorrow and Friday along with all of the homecoming festivities on Friday.

- 3) A motion was made by David Kujawa and seconded by Nikki Screws to approve a resolution nominating candidates for the Robertson County Appraisal District Board of Directors. This motion carried by a vote of 6-0.
- 4) The Board convened into closed session at 7:35 pm to discuss personnel – 551-074
- 5) The Board came out of closed session at 8:05 pm.
- 6) A motion was made by Jennifer Coburn and seconded by Nikki Screws to adjourn the meeting. This motion carried by a vote of 6-0. The meeting was adjourned at 8:06 pm.
