

Item VII The following items were action items.



Purpose of the Meeting:

Bremond ISD will be applying for the American Rescue Plan ESSER III Federal Stimulus Money and is required to have a planning meeting on the spending of funds.

The purpose of the grant:

To help safely reopen school, to sustain the safe operation of schools, address the impact of the academic performance of students due to the COVID-19 pandemic and address the social/emotional needs of students and staff due to COVID-19.

Grant Timeline for Spending of Funds: March 13, 2020 to September 30, 2023 with a carryover year to September 30, 2024

Amount of Funding: Total Award: \$1,065,188.00
2/3rds of Award: \$852,150.40 (what the 2021-2023 application will be applied for at this time)
Last 1/3 will come at a later time after TEA sends in their plan to USDE
20% of funding is required for Instruction (calculated on the 2/3rds amount):
\$213,037.60

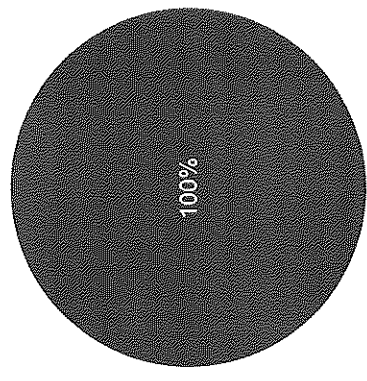

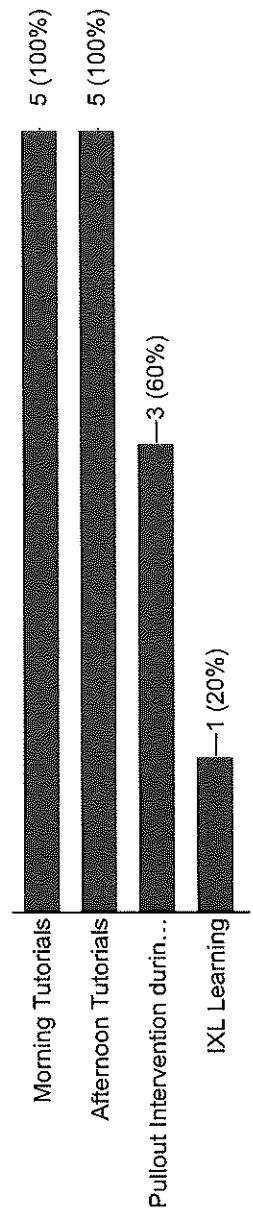

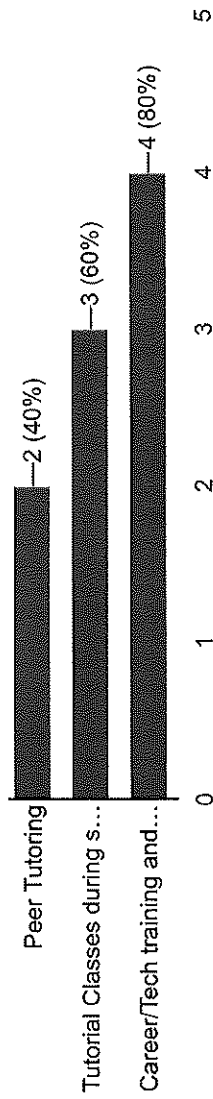

Please select the academic strategies that you consider vital to addressing learning loss during COVID-19. Check all that you want considered. * *

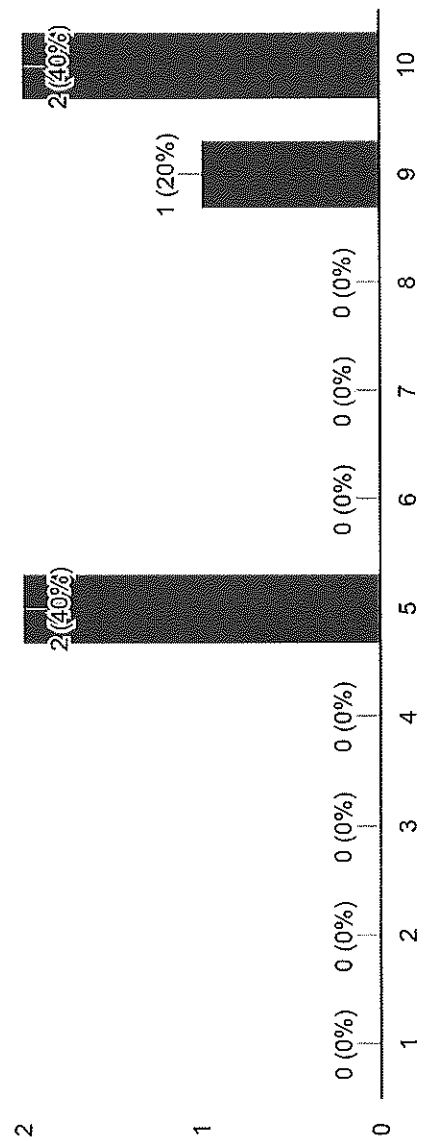

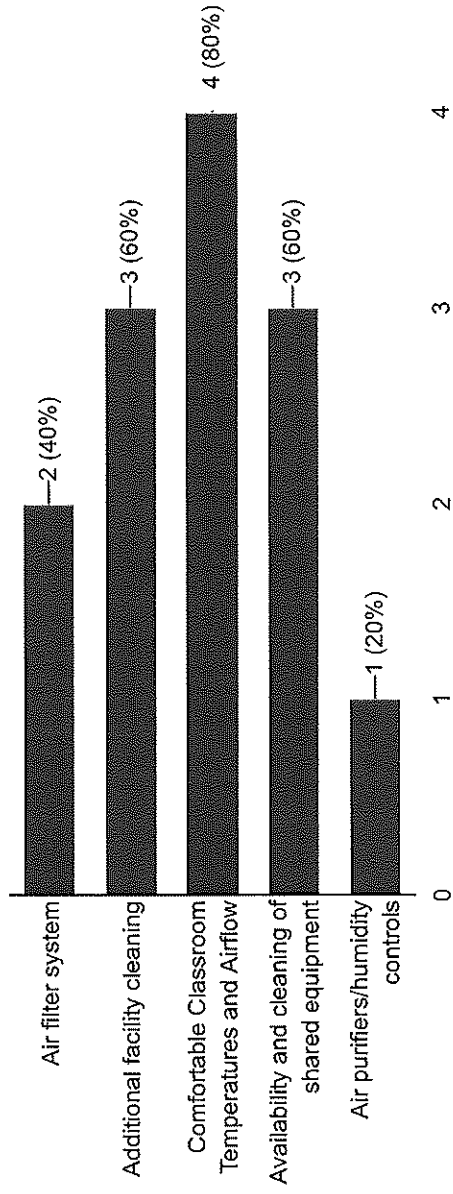

1. Randy Yanowski spoke of a need for student services personnel to help the students that have fall behind due to the impact of COVID on families. He also spoke of HVAC issues that needed to be addressed so that students would be comfortable in their learning environment.
2. Misti Swick spoke on a need for math intervention for students that have struggled due to at home learning. She also spoke of a need for an additional career and technology teacher. Dally Rieger expressed her desire to take animal science along with Anna Drews. Due to being unable to social distance properly students are unable to take the classes they need and desire.
3. Troy Mitchell spoke on the issues inside his classroom with student attitudes with the lack of cleaning due to the heavy focus on sterilization.
4. Reagan Burnett expressed the lack of a GT program for the kids that needed more and often get overlooked because of the other kids that struggle.
5. John Burnett spoke on sanitizing needs in the cafeteria and stipends retentions for staff. Due to the work overload that COVID has caused.
